Re: emails received from Nikolai Repine

I am writing to you as Head of the Lawyers and Conveyancers Tribunal about the attached emails, received by three of the members who presided in the hearing of disciplinary charges against you recently.

An internet search of the author's name reveals that he is a client of yours. The emails were sent before the decision was published on the Tribunal's website, so it may be that you supplied it to Mr Repine. That is not the issue, given your pending suspension, it is to be expected that you would need to inform clients with upcoming matters of your situation.

The concern is that the content of the emails clearly fall within the contempt provisions of the Lawyers and Conveyancers Act 2006, s 251(1)(a), since they are "wilfully insult(ing)". This conduct will not be tolerated and the purpose of this letter is to invite you to refer this provision to your client and advise him that any further attempt on his part to contact members of the Tribunal, will be met with a referral to the relevant authorities.
