Dear Registrar,

In its final judgment the Supreme Court made an order prohibiting publication of the identity of the parties until further order of the High Court. As a consequence and in accordance with that order the High Court has heard an application for non-publication orders and reserved its decision to be delivered in writing in due course.

In addition, to protect fair trial rights the Supreme Court made further non publication orders which are to remain in force until final disposition of the matter by the trial court which in this case is the High Court. That order is an interim order only but remains extant as the matter has not yet been disposed of by trial or otherwise. When the matter has been finally disposed of the order will cease to have effect, thus the principles relied on by the "appellant" are not engaged. It should also be noted these orders do not prohibit publication in a Law report or Law Digest.

The appeal and the issue of publication is no longer before the Supreme Court. The Supreme Court has no matters remaining over which it can exercise jurisdiction and accordingly given it has delivered a final judgment it is functus officio
